**Introduction:** Karnataka State Board of Auqaf is a Statutory Body established during the year 1961. The main objective of the Board is supervision and safeguarding Waqf properties by ensuring an effective and efficient administration. It comprises of Chairman and 10 Members.

#### **Functions & duties:**

- 1) Registration of the Waqf institution.
- 2) Constitution of Managing Committee/Appointment of Muthawalli for the management of Waqf institution.
- 3) Protection of Waqf property.
- 4) Development of properties of the Waqf institution.
- 5) Recovery of Waqf property transferred in contravention of Section 51 of the Waqf Act 1995.
- 6) Removal of Encroachments in Waqf properties.
- 7) Conducting survey of Waqf properties.
- 8) Updating of records of Waqf properties.
- 9) Approval of budget of Waqf institution.
- 10) Any other activities necessary for control, maintenance & superintendence of Waqf.

#### **Computerization programme:**

32550 Waqf Institutions have been registered under the Karnataka State Board of Auqaf and these institutions have 47270 properties. The computerization of all information relating to the Karnataka State Board of Auqaf under Central Sponsored Scheme is in progress.

As per the Government of India the data pertaining to Waqf institutions is entered in modules of Waqf Administration Management System of India (WAMSI) on the following issues.

1. Property management.
2. Muthawalli management.
3. Leasing of property management.
4. Litigation tracking system management.

5. Archive management.
6. Grant-in-Aid of Waqf properties.
7. Fund management.
8. Loan management of Urban Waqf properties.

**Survey:**

As per Section 4 of the Waqf Act 1995 survey is to be conducted once in 20 years. The State Government vide Notification No. RD 57 WES 97, dated:-18-08-1997 has appointed the Secretary to Government, Revenue Department as the Survey Commissioner of Waqfs. The Deputy Commissioner of the District, City Corporation and City Municipal Councils are appointed as Additional Survey Commissioner of Waqfs respectively. The Assistant Commissioner and Tahsildar, District Waqf Officers, Waqf Inspector, Chief Officer are Assistant of the Survey Commissioner of the Waqfs.

**Methodology of Survey:**

The District Waqf Officers and Surveyor shall prepare a Sketch/Map, after due notice to interested parties, fill up all the details of the properties in Form No.1.

Submit the same for the validation of the Tahsildar/Taluk Panchayath Officer/CMC/TMC/ concerned Officers.

Submit for counter-signature of the Assistant Commissioner and onward submission to the Deputy Commissioner.

If any objections received, the same shall be enquired as per Section 4 (3) 4(4) & 4(5) of the Waqf Act 1995.

The Deputy Commissioner (Addl. Survey Commissioners) shall examine and send the same to the Waqf Board.

**2<sup>nd</sup> Survey:**

The second survey of Waqf properties is under process.

The objective is to conduct re-survey of the properties surveyed in the year 1964-65.

There are 32550 Waqf properties in the state and out of which up to end of Jan. 2014 19721 properties have been surveyed.

**Constitution of Managing Committee/Appointment of Muthawalli**

The State Board of Auqaf functions as per the Provisions of the Waqf Act 1995 (2013) as amended from time to time.

Guidelines and follow up procedures have been issued time to time by the Board and the proposals of Managing Committee are constituted as per the guidelines of the Circular.

District Waqf Office/Karnataka State Board of Auqaf issued Public Notice the form a Managing Committee calling for objections. When objections are received they are heard as per above Circular Sub-Committee has been constituted for Managing Committee and other related issues and the proposals for the Managing Committee

renewal and approval of Sub-Committee. After the approval from Sub-Committee orders are issued and the matter will be placed before the Board for confirmation.

Regarding appointment of Muthawalli, the provisions of Waqf Act are followed.

### **Grant-in-Aid to Waqf properties/Protection of Waqf properties**

Yearly programmes are framed in the MPIC format as per the allotted grants. Head of the Dept will implement the scheme as per MPIC.

Period:

For each scheme MPIC programmes are devised and Annual Programmes are implemented as per MPIC.

Civil chapter/service chapter etc:

Every month under the Chairmanship of the Principal Secretary, Minority Welfare Department the progress of the Dept will be reviewed. Apart from MPIC, progress will be implemented as per the RFD and the same will be reviewed in the meetings headed by the Chairman of Adhoc Task Force.
